A third area of concentration is health. UWLS supports programs that improve and promote a healthier lifestyle, providing access to health services and nutrition resources to support opportunities for a healthy lifestyle. They also support access to healthcare and preventative care.

United Way of Lake and Sumter Counties, Inc. also provides financial assistance for rent and utilities to individuals who have been impacted by the COVID-19 pandemic and relating economic hardships.
